RESOLUTION AUTHORIZING ENTERING INTO A PROFESSIONAL SERVICES AGREEMENT (PSA) BETWEEN THE CITY OF FLINT AND ELIZABETH S. MURPHY

In order to provide continuity of services to infrastructure and development activities, the Emergency Manager has determined that it would be advantageous for the City to employ the services of Elizabeth S. Murphy in the capacity of Administrative Aide/Infrastructure and Development; and

The duties shall be pursuant to the PSA, and any other duties that may be required by the Emergency Manager; and

The PSA shall be effective beginning on December 19, 2011 and ending on March 19, 2012, inclusive; and

Compensation shall be at the rate of \$20.00 per hour and shall be drawn from several municipal and grant funds to be determined at the descretion of the Emergency Manager. For income tax and accounting purposes, a Form 1099 shall be provided reporting her gross wages from the City of Flint; and

The Administrative Aide/Infrastructure and Development shall not receive any fringe benefits. Compensation for services provided is limited to the hourly wage agreed upon.

IT IS RESOLVED, that the Emergency Manager shall, on behalf of the City of Flint, enter into a PSA with Elizabeth S. Murphy commencing December 19, 2011 and ending March 19, 2012. Agreed upon compensation is \$20.00 per hour, with no fringe benefits. Compensation shall be drawn from several municipal and grant funds to be determined at the descretion of the Emergency Manager, and a Form 1099 shall be provided for income tax and accounting purposes.
