This is to serve as an addendum to the Memorandum of Understanding between the Genesee County Land Bank Authority and the City of Flint dated June 7, 2011.

WHERE AS, the City of Flint is currently under contract by the Genesee County Land Bank Authority to perform demolition of residential structures owned by the Land Bank located in the City.
