During April, 2010, the City hired new program management staff for assignment to the NSP1 program. Subsequently, a monitoring review was conducted by HUD after new staff was hired to manage the NSP1 program. During HUD's review, it was recommended by HUD that the new program management staff lacked the capacity to manage the NSP1 program and suggested that City retain Community Improvement Group, LLC., for program management services.

Community Improvement Group, LLC. was retained by the City and a contract for \$244,916.00 was executed for services beginning July, 2010 through September, 2011. Two payments totaling \$13,686.25 are due to the organization at this time. Upon receipt of payment, the organization is to return all documents pertaining to program management services for the NSP1 program.
