BY THE EMERGENCY MANAGER:

The City of Flint Neighborhood Stabilization Program (NSP1) grant B-08-UN-26-0005 was monitored by the U.S. Department of Housing and Urban Development in May 2011 and July 2012. The City was cited with two finding that required repayment of \$98,079.15.

Resolution 2012EFM093 authorized repayment of \$98,079.15. The payment was made on October 25, 2012 and is now available in the Disaster Recovery Grant Reporting System (DRGR).



Department of HUD in the Disaster Recovery Grant Reporting System (DRGR) and establish like NSP1 funds on the City's BS&A system in revenue account 297-747.100-502.747 and expense account 297-747.100-700.100 – NSP1 Uncommitted funds.


