**Resolution Authorizing Change Order # 1 to cancel spending authority for a contract (10-022) to ASTI Environmental financed using Neighborhood Stabilization Program Round 1 Funding (NSP1)**

**BY THE EMERGENCY FINANCIAL MANAGER:**

During 2010, a contract in the amount of \$30,000.00 was executed between the City of Flint and ASTI Environmental for lead and asbestos testing services using Neighborhood Stabilization Round 1 Funds.


Services were rendered from the firm and the contract with ASTI expired on June 30, 2011. The funds remaining on this agreement, (\$18,070.00) will be used at a later date to finance the redevelopment of home located in NSP areas.

Funds are to be cancelled from the following accounts: 297-747.458-502.747 and 297-747.458-805.327 labeled as Neighborhood Stabilization Program Round 1 revenue and expense accounts, respectively.


Funds are to be reprogrammed in accounts 297-747.100-700.100 (expense account) and 297-747.100-502.747 (revenue account) labeled as Uncommitted NSP Round 1 funds.

IT IS RESOLVED, that City Officials are authorized to cancel spending authority in the amount of \$18,070.00 included in a contract (10-022) to ASTI Environmental financed using Neighborhood Stabilization Program 1 funding.






