## RESOLUTION

The goal of the City's Neighborhood Stabilization Program 1 (NSP-1) is to restore vitality to distressed neighborhoods by facilitating the acquisition, rehabilitation and resale of vacant and foreclosed single family homes.

The Transportation-Development Department is a department within the City of Flint that handles all demolitions for the City's Neighborhood Stabilization Program and received a contract award (10-034) in the amount of \$300,000 for the purpose of implementation of a demolition plan to address abandoned and foreclosed homes in the City's approved NSP areas.

The first contract change order (10-034A) added an additional fifty six (56) demolitions and increased the contract amount to \$710,000 that expired on December 31, 2011.

The second contract change order (10-034B) increased the contract amount to \$920,000 that expired on December 31, 2011. The Transportation-Development Department has requested a second extension to its initial demolition contract due to many obstacles faced by both the City and the Transportation-Development Department which prevented the department from expending funds within the time frame outlined in the demolition contract. An additional one year time extension is necessary for the City and Transportation-Development Department to meet the goals and objectives of the NSP-1 program.

Funding available to reimburse Transportation-Development Department for the NSP-1 eligible and reasonable expenses is available in the expense account 297-747.150-805.076.
