**RESOLUTION TO AMEND THE CITY OF FLINT'S 2011-2012 ACTION PLAN
AND ENTER INTO CONTRACTS WITH VARIOUS AGENCIES.**

The City of Flint has identified that \$365,000 in uncommitted CDBG funds is available for reprogramming; account number 272-748.101-700.100.

The City of Flint proposes to reprogram funds to the following activities in the amounts identified below:

Flint Area Enterprise Community (FAEC) is to receive a CDBG allocation of \$45,000.00, revenue account 272-748.310-502.748 & expense account 272-748.310-805.502.

Local Initiatives Support Corporation (LISC) is to receive a CDBG allocation of \$15,000.00, revenue account number 272-748.425-502.748 & expense account 272-748.425-805.502.

Big Brothers Big Sisters (BBBS) is to receive a CDBG allocation of \$60,000.00, revenue account number 272-748.272-502.748 & expense account number 272-748.272-805.105; and

City of Flint Police Department – Police Activities League is to receive a CDBG allocation of \$45,000.00, revenue account number 272-748.220-502.748 & expense account number 272-748.220-805.101.

City of Flint – Department of Transportation is to receive a CDBG allocation of \$200,000.00 for sidewalk repairs, revenue account number 272-748.235-502.748 & expense account number 272-748.235-805.063.

These changes constitute a substantial amendment to the City of Flint's 2011-2012 Action Plan. As such a 30-day comment period was held.

IT IS RESOLVED, that City of Flint officials are authorized to do all things necessary to amend the City of Flint's 2011-2012 Action Plan & to enter into contracts with the aforementioned agencies in the amounts identified above for a cumulative total amount of \$365,000.

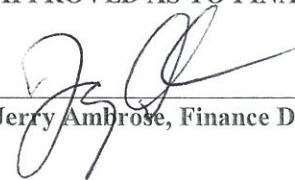

Background/Summary of Proposed Action: Upon review of proposed uses of funds identified in the City of Flint's 2011-2012 Action Plan, the City determined that modifications are needed and is recommending changes to the proposed uses of CDBG. A previous resolution canceled several of the activities proposed in resolution #111006. The attached resolution authorizes the City of Flint to amend the City's action plan and allocate funds to the following activities. The list below identifies the new activities and proposed amounts.
