Re: Liquor License request for 836 S. Saginaw St.

Attached you will find the Liquor License Request for a business by the name of Allejandro, LLC whose request was on file with the Michigan Liquor Control Commission. The request is to **Transfer ownership of an escrowed 2011 Class C licensed business from Pavjo, LLC**. The necessary paperwork has been completed and approved by the appropriate city departments **with the exception** of Building & Safety Inspections. The reason for their DISAPPROVAL is that it located within 1000 feet of a Church.

Please be advised that this business located at 836 S. Saginaw St. is **NOT** a new liquor establishment, but an existing one. They are only transferring ownership of the business. This is a 2 Step Process. **Step 2 is Transferring ownership from Pavjo, LLC to Allejandro, LLC.** Step 1 is to Transfer ownership from Bailiwick Pub and Grill, Inc. to Pavjo, LLC.

In any event, I would appreciate if you would kindly approve this Liquor License Application. I ask that once this application is approved, that you would please return it back to the City Clerk's Office so that further paperwork can be done to forward the packet to the Michigan Liquor Control Commission for approval.
