
**RESOLUTION TO ALLIE BROTHERS FOR POLICE UNIFORMS**

The Department of Purchases & Supplies has solicited bids for uniforms as requested by the Police Department; and





**Background/Summary of Proposed Action:** Resolution authorizing the Director of Purchases & Supplies, upon the Emergency Managers approval, to issue a purchase order to Allie Brothers Inc., who was low bidder, as requested by the Flint Police Department, for uniforms in the amount of \$93,968.40. The majority of the officers' uniforms are weathered and faded which doesn't leave a good impression with the citizens of Flint. The new uniforms are budgeted in two JAG Grants. (General Fund)

**Note:** All Police Grants Funds are set-up in the General Fund except for the COPS Hiring Recovery Grant.

**Financial Implications:** Funding is coming from the 2009 JAG Local Solicitation Grant and 2009 JAG Recovery Act Grant. There is no cost to the City.
