

Resolution 091048, adopted on September 28, 2009, authorized the Department of Community and Economic Development to award Metro Housing Partnership \$12,500.00 of HOME Investment Partnerships Program (HOME) funds for administrative support of the Tenant Based Rental Assistance program. The funds were awarded for use through June 30, 2010. No contract was executed for administrative support and the Tenant Based Rental Assistance contract 08-171 has expired.

The Department of Community and Economic Development requests \$12,500.00 HOME administrative funds are reprogrammed from Metro Housing Partnership revenue account 238-749.442-502.749 and expense account 238-749.442-805.452 to City of Flint HOME Administration revenue account 238-749.100-502.749 and expense account 238-749.100-805.502 for use in the administration of the department.

IT IS RESOLVED, That appropriate City Of Flint officials are authorized to do all things necessary to process a reprogram \$12,500.00 from Metro Housing Partnership revenue account 238-749.442-502.749 and expense account 238-749.442-805.452 to City of Flint HOME Administration revenue account 238-749.100-502.749 and expense account 238-749.100-805.502 for use in the administration of the department.
