

Funding will come from the following accounts: 101-753.200-726.000 (\$12,000), 202-443.201-726.000 (\$25,000), 590-540.208-726.000 (\$650), 591-540.202-726.000 (\$650), 591-545.201-726.000 (\$8,000) and the following accounts will be used to establish inventory: 661-000.000-110.400 (\$5,000), 590-000.000-110.200 (\$18,000), 591-000.000-110.500 (\$15,000); and

IT IS RESOLVED, That the Department of Purchases & Supplies, upon the Emergency Manager's approval, is hereby authorized to issue purchase orders to McNaughton-McKay Electric for the second year of a three year pricing agreement for the annual supply of electrical supplies in the amount not to exceed \$84,300.00. (Fleet/Central Garage Fund, Sewer Fund, Water Fund, General Fund, Major Street Fund)




