**RESOLUTION APPROVING THE COVERING OF INELIGIBLE EXPENSES CREATED BY
THE ACCEPTANCE OF THE 2011 SAFER GRANT FROM THE FEDERAL EMERGENCY
MANAGEMENT AGENCY AND DEPARTMENT OF HUMAN SERVICES,**

BY THE EMERGENCY MANAGER:


WHEREAS, The Flint City of Flint Fire Department has been notified that its SAFER Grant application has been awarded funding through the Federal Emergency Management Agency and the Department of Human Services, for a two (2) year period beginning June 10, 2012 and ending June 9, 2014, in the amount of \$6,900,270.00; and

WHEREAS, The Flint City Fire Department is required to cover the ineligible cost for the 39 SAFER Grant funded fire fighters in the amount of \$41,791.00 for the period listed above.


THEREFORE BE IT RESOLVED, That the City of Flint Fire Department will suspend the appointment of the position of Safety Training Officer for a (5) five month period beginning June 10, 2012 and ending December 1, 2012 for the purpose of creating the necessary funds to off set the cost of ineligible expenses. The revenue created by delaying the appointment of a Safety Training Officer; \$9,692.00 per month; Wages (\$5,974.00) and Direct Fringes (\$3,718.00). Total savings for a five (5) month period is \$48,460.00 from 101 General Fund Fire 337.202

IT IS FURTHER RESOLVED, That the Assistant Chief of the Fire Department will assume the safety duties performed by the Safety Training Officer and the Assistant Chief and Emergency Medical Service Supervisor will assume the mandatory fire fighter training as required by MIOSHA. At the end of the five (5) month period, the City of Flint will begin the process of filling the vacant position.
