## Resolution Recognizing Receipt of and Appropriation and use of Revenues for City of Flint Participation in the Law Enforcement Officers Regional Training Commission

## BY THE EMERGENCY FINANCIAL MANAGER:

The City of Flint, through its Police Department, has participated in the Law Enforcement Officers Regional Training Commission (LEORTC) since its inception in 1983.

The LEORTC was created as a result of Public Acts 301 and 302 of 1982 (which acts created the Michigan Justice Training Commission and the Michigan Justice Training Fund) to provide police officer "in-service" training programs for the police agencies throughout the area. Participating agencies fund the training cost by paying the LEORTC.

The City of Flint Police Department has been notified that the Law Enforcement Distribution authorized by the Michigan Justice Training Fund has been received. The Flint Police Department received \$11,648.10 in FY12 and appropriated in FY13; also \$11,521.41 was received in FY13 for their share of the MJTC distribution, which were both deposited into revenue account 101-305.201-539.000. Payment in like amount to LEORTC will come from the police operating account 101-305.201-969.000.

**THEREFORE BE IT RESOLVED**, That City Officials are authorized to do all things necessary to recognize revenues in the amount of \$11,521.41in the appropriate revenue account and that appropriation in like amount be made in the Flint Police General Fund (101 FD) Operating Budget.

**BE IT FURTHER RESOLVED**, That City officials do all things necessary to approve payment to L.E.O.R.T.C. in the amount of \$23,169.51 from the FY-13 General Fund (101FD) Police Budget for continued participation in said organization.
