RESOLUTION AUTHORIZING CHANGE ORDER #2 TO ZITO CONSTRUCTION TO EXTEND CONTRACT EXPIRATION DATE

BY THE EMERGENCY MANAGER:

On November 23, 2012, the Emergency Financial Manager authorized the Proper City Officials to enter into a contract with Zito Construction, 8033 Fenton Road, Grand Blanc, Michigan, for the demolition of 17 structures in an amount not to exceed \$99,100.00, as requested by the Department of Infrastructure/Development; and


On November 28, 2012, the of Infrastructure/Development executed Contract #12-121 with Zito Construction for the demolition of the 17 structures utilizing 542-741.150-801.000 NSP3 in the amount of \$99,100.00; and

On February 22, 2013, the Emergency Financial Manager authorized the Proper City Officials to process Change Order #1 to said contract to extend the expiration date from February 22, 2013 to April 22, 2013; and

Due to requirements for environmental clearances and environmentally sound demolition practices, more time is required for Zito Construction to provide the necessary notifications to the appropriate State officials to complete the contract. The Department of Infrastructure/Development requests that the time frame be extended for Zito Construction's NSP3 contract as it relates to Bid #12-077, from April 22, 2013 to May 22, 2013; and

IT IS RESOLVED that the Proper City Officials, upon the Emergency Manager's approval, are authorized to enter into Change Order #2 to the aforementioned contract #12-121 with Zito Construction to extend the expiration date from April 22, 2013 to May 22, 2013.


