***Resolution authorizing the enactment of the second half of the Metro  
Community Development Contract.***

**BY THE EMERGENCY MANAGER:**

The City of Flint was previously awarded the Flint 21<sup>st</sup> Century Community Policing Grant, #2009-01027.03, from the Charles Stewart Mott Foundation for the period July 2012 through December 31, 2012. On January 7, 2013 the City approved an extension of the same grant, #2009-01027.04, starting January 01, 2013 through June 30, 2013. Within this grant a Neighborhood Safety Officer Coordinator position was allocated in the amount of \$45,000.00, \$22,500.00 for the first 6 six months and \$22,500.00 for the second six months.

The City has a contract with Metro Community Development in the amount of \$45,000.00 to work as the Neighborhood Safety Officer Coordinator for the Flint 21<sup>st</sup> Century Community Policing Grant. The City approved the first six months in the amount of \$22,500.00 on Resolution 2012EFM150 dated 11/16/12. The second half of the contract was to be enacted upon the city receiving the six month extension of the 21<sup>st</sup> Century Community Policing Grant. The Flint Police Department is now requesting the authorization to enact this second half of the contract.


**IT IS RESOLVED**, That the Emergency Manager, on behalf of the City of Flint, authorizes the appropriate City of Flint officials to do all things necessary to enact the second half of the Metro Community Development contract in the amount of \$22,500.00.


