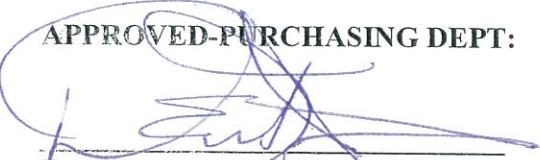
The Department of Purchases & Supplies has solicited bids for (3) year uniform, floor mat, and linen rental services as requested by various departments; and

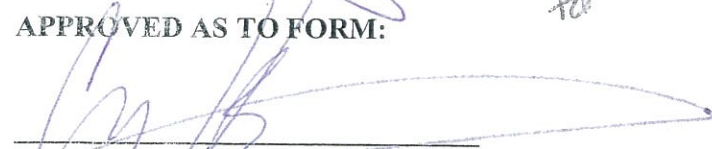

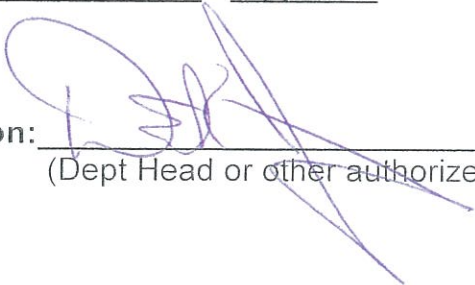
