An ordinance to amend the Code of the City of Flint by amending Chapter 18, Taxation; Funds; Purchasing, Article I, In General, Section 18-4.1, Service Charge in Lieu of Taxes for Housing Facilities for Certain Persons.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. That the Code of the City of Flint shall be amended by amending Chapter 18, Taxation; Funds; Purchasing, Article I, In General, Section 18-4.1, Service Charge in Lieu of Taxes for Housing Facilities for Certain Persons, by the addition of subsection (p), which shall read in its entirety as follows:

ARTICLE I. IN GENERAL

§18-4.1 SERVICE CHARGE IN LIEU OF TAXES FOR HOUSING FACILITIES FOR CERTAIN PERSONS.

(P) THE CITY ACKNOWLEDGES THAT FRONTIER DEVELOPMENT GROUP, LLC, A MICHIGAN LIMITED LIABILITY COMPANY ON BEHALF OF MICHIGAN LIMITED DIVIDEND HOUSING ASSOCIATION LIMITED PARTNERSHIP TO BE FORMED (THE "SPONSOR") HAS OFFERED, SUBJECT TO RECEIPT OF A MORTGAGE LOAN AND/OR ALLOCATION OF LOW INCOME HOUSING TAX **CREDITS** THE MICHIGAN FROM STATE HOUSING DEVELOPMENT AUTHORITY ("MSHDA"), TO ERECT, REHABILITATE, OWN AND OPERATE A **76-UNIT** HOUSING DEVELOPMENT **IDENTIFIED** AS **PHOENIX** APARTMENTS ON CERTAIN PROPERTY LOCATED IN THE CITY TO SERVE PERSONS OF LOW INCOME, WITH A **PARTICULAR TARGET** POPULATION OF HOMELESS VETERANS, AND THAT THE SPONSOR HAS OFFERED TO PAY THE CITY ON ACCOUNT OF THIS HOUSING DEVELOPMENT AN ANNUAL SERVICE CHARGE FOR PUBLIC SERVICES IN LIEU OF ALL TAXES.

THE CITY ACKNOWLEDGES THAT THE PHOENIX APARTMENTS SHALL BE AFFORDED TAX BENEFITS OF PAYING A SERVICE CHARGE IN LIEU OF TAXES. THE CITY FURTHER **ACKNOWLEDGES THAT PHOENIX APARTMENTS FITS** WITHIN THE CLASS AS DESCRIBED IN **§18-4.3** THE BELOW. ANNUAL SERVICE CHARGE FOR THE CLASS OF PERSONS OF LOW INCOME SHALL BE EQUAL (6%) **OF** TO SIX PERCENT THE DIFFERENCE **BETWEEN** THE CONTRACT RENTS ACTUALLY COLLECTED AND UTILITIES: HOWEVER, THE SERVICE CHARGE SHALL NOT EXCEED TAXES WHICH WOULD BE PAID ABSENT THIS TAX EXEMPTION.

(P) THE CITY ACKNOWLEDGES THAT FRONTIER DEVELOPMENT GROUP, LLC, A MICHIGAN LIMITED LIABILITY COMPANY ON BEHALF OF MICHIGAN LIMITED DIVIDEND **ASSOCIATION** HOUSING LIMITED PARTNERSHIP TO BE FORMED (THE "SPONSOR") HAS OFFERED, SUBJECT TO RECEIPT OF A MORTGAGE LOAN ALLOCATION **OF** LOW AND/OR HOUSING TAX INCOME CREDITS THE **MICHIGAN** FROM STATE HOUSING DEVELOPMENT AUTHORITY ("MSHDA"), TO ERECT, REHABILITATE, OWN AND OPERATE A **76-UNIT** HOUSING DEVELOPMENT AS **IDENTIFIED PHOENIX** \mathbf{ON} **APARTMENTS** CERTAIN PROPERTY LOCATED IN THE CITY TO SERVE PERSONS OF LOW INCOME, **PARTICULAR** WITH A TARGET POPULATION OF HOMELESS VETERANS, AND THAT THE SPONSOR HAS OFFERED TO PAY THE CITY ON ACCOUNT OF THIS HOUSING DEVELOPMENT AN ANNUAL SERVICE CHARGE FOR PUBLIC SERVICES IN LIEU OF ALL TAXES.

THE **CITY ACKNOWLEDGES** THAT THE PHOENIX APARTMENTS SHALL BE AFFORDED TAX BENEFITS OF PAYING A SERVICE CHARGE IN LIEU OF TAXES. THE CITY FURTHER ACKNOWLEDGES THAT **PHOENIX** APARTMENTS FITS WITHIN THE CLASS AS DESCRIBED IN **§18-4.3** THE BELOW. ANNUAL SERVICE CHARGE FOR THE CLASS OF PERSONS OF LOW INCOME SHALL BE EQUAL SIX PERCENT (6%) OF DIFFERENCE **BETWEEN** THE CONTRACT RENTS ACTUALLY COLLECTED AND UTILITIES; HOWEVER, THE SERVICE CHARGE SHALL NOT EXCEED TAXES WHICH WOULD BE PAID ABSENT THIS TAX EXEMPTION.
