***Resolution to accept an increase and extension of the Charles Stewart Mott Foundation 21<sup>st</sup> Century Community Policing Grant***

**BY THE EMERGENCY FINANCIAL MANAGER:**

The City of Flint was approved on resolution number 2013EFM003 dated 01/07/13 to accept an increase and extension for the 21<sup>st</sup> Century Community Policing Grant 2009-01027.04 from the Charles Stewart Mott Foundation in the amount of \$742,520.00 bringing the total grant amount to \$1,485,520.00.

As of July 01, 2013, the Charles Stewart Mott Foundation has awarded the City of Flint an additional increase and extension to the 21<sup>st</sup> Century Community Policing Grant, grant extension number 2009-01027.05, in the amount of \$235,700.00, for an adjusted grant total of \$1,721,220.00, with a revised grant end date of June 30, 2014.

**IT IS RESOLVED**, That the appropriate City Officials, upon the Emergency Managers approval, are hereby authorized to do all things necessary to accept this grant increase and extension between C.S. Mott Foundation and the City of Flint in the amount of \$235,700.00 for the 21<sup>st</sup> Century Community Policing Program with the revised grant end date of June 30, 2014.
