Background/Summary of Proposed Action:

On July 1, 2013, the City's general liability insurance policy with Starr Indemnity expired with non-renewal notification from the carrier. Applications were made to several carriers.

On August 1, 2013, the Lake Agency obtained a quote from carrier Munich Re with three different plan options. Upon review by both the Finance Director and City Attorney, it is agreed that Option 3 best meets the City's needs.

<u>Financial Implications</u>: The cost of the prior year's policy was \$163,400 for a limited \$1,000,000 in excess coverage with \$1,000,000 SIR. Option 3 will provide greater coverage at \$10,000,000 excess coverage and \$3,000,000 SIR. Funding is available in the self-insurance fund to cover the increased cost.
