Background/Summary of Proposed Action:

The barscreen and compactor equipment is needed at the North West pumping station to allow WPC to enable WPC to reliably screen debris out of the incoming wastewater and discharge into a roll off container that will be taken to landfill. Current equipment is old, obsolete, and some parts have already been taken out of service. This is a critical part of the pumping station as the screen protects the valuable pumps from debris that could cause the pump station to flood or potentially harm the pump.
