CONTRACT WITH GENESEE COUNTY FOR BRENNAN SENIOR CENTER.**


BY THE EMERGENCY MANAGER:

The City of Flint has applied for and been approved to receive \$113,826.00 from the Genesee County Office of Senior Services. Funds must be used through Brennan Senior Center for services that improve the health, safety, and quality of life for Genesee County residents aged 60 years or older.

Funds must be utilized in accordance with the Plan for Genesee County Senior Citizen Services Millage, and are provided on a reimbursement basis upon proper monthly submission of reimbursement request reports during the period of October 1, 2013 through September 30, 2014.



Financial Implications: Timely submission and program compliance are required for full reimbursement to occur.


