***Resolution authorizing a change order to extend and increase the Metro  
Community Development Contract***

**BY THE EMERGENCY MANAGER:**

The City of Flint was awarded the 21<sup>st</sup> Century Community Policing Grant 2009-01027.03 on July 01, 2012 from the C.S. Mott Foundation. The 21<sup>st</sup> Century Community Policing Grant has been increased and extended the past two years bringing the grant total to \$1,721,220.00 with an end date of June 30, 2014.

A Neighborhood Safety Officer Coordinator position has been written into the grant since its inception. The City of Flint had contracted with Metro Community Development through June 30, 2013 in the amount of \$45,000.00 for said position. Upon receiving this grant extension, the City would like to enter into a change order to continue the Metro Community Developments contract by extending it through June 30, 2014 with an increased amount of \$22,500.00 for a revised total of \$67,500.00.


This increase of \$22,500.00 has been allocated for a Neighborhood Safety Officer Coordinator in grant extension 2009-01027-05 which was approved by resolution number EM0612013 dated 08/15/13. This amount has been budgeted in the City of Flint Police Grant account 296-315.702-801.000.

**IT IS RESOLVED**, That the Emergency Manager shall, on behalf of the City of Flint, authorize the appropriate City of Flint officials to do all things necessary to enter into a change order with Metro Community Development to work as the Neighborhood Safety Officer Coordinator for the Flint 21<sup>st</sup> Century Community Policing Grant, #2009-010273.05, through June 30, 2014 in the amount of \$22,500.00 for a revised total of \$67,500.00.
