Whereas, the Office of the City Clerk was notified by the Flint Board of Education that three schools – Washington, Bryant and Zimmerman elementary schools – were to be closed; and

Whereas, effective with the November 5, 2013, election, new facilities need to be secured to replace them; and

Whereas, the Office of the City Clerk recently received last minute notification that Manley and Summerfield elementary schools are no longer under the jurisdiction of the Flint Board of Education thus creating a need to replace them as well; and

Whereas, the Office of the City Clerk spent extensive time locating new polling sites, and new ones have been identified and approved by the Flint Election Commission.

Now, Therefore, Be It Resolved, that the Emergency Manager approves the relocation of polling sites that were previously located at Washington, Bryant, Zimmerman, Summerfield and Manley elementary schools and will now be located at Mott Community College Technology Center, Hasselbring, Eisenhower, Haskell/Bethel Church and Freeman, respectively (see attached).
