Resolution to cancel spending authority and revenue recognition for various ESG contracts

Background/Summary of Proposed Action:

Metro Community Development is the administrator of the Michigan State Housing Development Authority (MSHDA) Emergency Solutions Grant (ESG) program as well as the lead agency for the Flint-Genesee County Continuum of Care. The City has determined that it would be cost effective to contract with Metro to provide fiduciary and administrative oversight of the City of Flint Emergency Solutions Grant program. On August 20, 2013, the City adopted Resolution EM0622013 entering into a Memorandum of Understanding with Metro Community Development authorizing paying Metro Community Development \$11,000 to administer the 11-12, 12-13, and all previous ESG balances. The City has processed other resolutions authorized canceling spending authority and revenue recognition to make administration funds available to Metro, as well as authorizing entering into a contract for this amount.

In addition to transfering administrative funds, the City needs to cancel agency spending authority for the balances on existing contracts and uncommitted funds so that Metro can enter into agreements with the respective agencies. The City will then pay only Metro for monthly expenses they, and the other agencies incur. The attached resolution authorizes canceling spending authority. The City will maintain revenue recognition because it will continue doing the monthly drawdowns. A subsequent resolution will authorize the transfer of all 11-12, 12-13, and remaining funds to Metro and to establish spending authority for the total amount in Metro's account.

Financial Implications (i.e., budget, account information)

With the approval of this resolution, the City will be authorized to cancel spending authority to make funds available for transfer to Metro Community Development.
