The City of Flint identified the National Service Fund of the Community Foundation of Greater Flint as a critical collaborative partner to help support the continued development and ultimate completion of a comprehensive Master Plan. The City of Flint identified and was awarded an opportunity through LISC AmeriCorps for the placement of a 10-month service member beginning October 1, 2013 through July 31, 2014. The grant funds act as the required cash match for the LISC AmeriCorps position, and additionally serve as matching support for the HUD Office of Sustainable Communities, Community Challenge Planning grant that was awarded to the City of Flint to develop a Master Plan. These matching funds will allow the planning staff to utilize the service member to ensure the completion of planning process Phase II: Implementation. This phase consists of the development of eight sub-area plans, a 5-year capital improvement plan, and full revision of the City's zoning code. The member will ensure continued community support, essential for the approval and adoption of all remaining parts of the master planning process.
