# **Background/Summary of Proposed Action:**

The purpose for which these resolutions are being presented is to consider approval of an Industrial Facilities Exemption Certificate for American Spiral Weld Pipe Company L.L.C. on a \$14,241,827 real and personal property investment and to set a public hearing to provide an opportunity for interested parties to comment on the request.

American Spiral Weld Pipe Company L.L.C. has submitted an application for an Industrial Facilities Exemption Certificate, under Public Act 198 of 1974 as amended. The company will operate and assume responsibility for all real and personal property taxes on a newly constructed 178,000 square foot facility designed to produce spiral welded steel water pipes. The facility will be located at 1225 E. Marengo and situated on the previous location of the Buick Powertrain North building 38. The project site is bounded by Pierson Road on the north, Stewart Avenue on the south and the C & O Railroad on the east. The company expects to employ 40 – 50 workers. The total project cost is \$14,241,827

American Spiral Weld Pipe Company L.L.C. is a wholly owned subsidiary of American Cast Iron Pipe Company based in Birmingham, AL.

# Financial Implications (Analysis):

Under Public Act 198, approval of an Industrial Facilities Exemption Certificate affords the holder an assessment of its new investment of real and personal property at 50 percent of the calculated true cash value.
