The City of Flint established the Historic District of the City of Flint (The "Commission") under Act 1969, Public Acts of Michigan, 1970 as amended; and

Pursuant to Article I, Section I, of the Flint Historic Commission By-Laws, the Historic District Commission shall consist of seven members appointed as provided in the City Charter and City Ordinance No. 2707; and

Emergency Manager Darnell Earley recommends appointment of Maurice Davis (1313 W. Dayton Street, Flint, Michigan, 48504) to serve a three-year term on the Historic District Commission commencing April 1<sup>st</sup>, 2014 and expiring March 31<sup>st</sup>, 2017.

**IT IS RESOLVED** that the Emergency Manager of the City of Flint, pursuant to the authority granted under Public Act 436, approves the appointment of Maurice Davis to serve a three-year term on the Historic District Commission commencing April 1<sup>st</sup>, 2014 and expiring March 31<sup>st</sup>, 2017.

**Agenda Item Title:** Resolution approving the appointment of Stephanie Wright to the Flint Historic District Commission.

**Background/Summary of Proposed Action:**

On December 12, 2013, The Land Bank held two community engagement meetings in the Civic Park neighborhood. These meetings were held to get feedback from the neighborhood on the potential boundary change to help with demolitions in the historic district area. At these meetings, the City of Flint asked for people who wanted to serve and represent the Civic Park neighborhoods, the City's largest historic district, on the Flint Historic District. Stephanie Wright applied and returned the application.

At the January 15<sup>th</sup>, 2014 Historic District Commission meeting, the applicant's applications were presented and reviewed by the commission. They suggested that all applicants attend the next meeting in February to introduce themselves to the commission.

At the February 6<sup>th</sup>, 2014 Flint Historic District Commission Ms. Wright was present She had the chance to introduce herself and answer any questions the commission had. The Commission thanked her for her time, effort and interest in the Flint Historic District Commission.

On the March 6<sup>th</sup>, 2014 meeting the Commission recommended appointment of Maurice Davis. The Commissioners were impressed with Ms. Wright as a candidate and felt that she would be a great addition to the commission.

Second Ward Councilwoman Jacqueline Poplar, who represents Civic Park, also recommended the appointment of Stephanie Wright to the Flint Historic District.

The Flint Historic Commission recommends the appointment of Stephanie Wright to the Flint Historic District Commission.
