Resolution Authorizing Appropriate City of Flint Officials to Do All Things Necessary to Enter into MDOT Contract 14-5130, Job No. 114111 for the Purpose of Fixing the Rights and Obligations of the Parties in Agreeing to Improvements for the Pierson Road CMAQ Phase II Project (Traffic Signal Upgrades)

BY THE EMERGENCY MANAGER:

MDOT has submitted to the City of Flint MDOT Contract 14-5130, Job No. 114111 to be executed between MDOT and the City of Flint for the purpose of fixing the rights and obligations of the parties in agreeing to improvements for the Pierson Road CMAQ Phase II Project that includes traffic signal upgrading work; concrete pavement repair, concrete curb and gutter, concrete sidewalk and sidewalk ramp work at the following locations: Pierson Road at Harvard Street, Saginaw Street, North Street, Industrial Avenue, Selby Street and Horton Avenue and all necessary related work. The estimated total project cost is \$474,100.00.

MDOT has indicated Federal Funds programmed under the Congestion Mitigation and Air Quality (CMAQ) shall be applied to the eligible items of the project costs at an amount not-to-exceed \$461,000.00. City of Flint shall be 100% responsible for payment of the remaining project costs, which are estimated to total \$13,100.00.

The Department of Public Works is requesting that appropriate City officials be authorized to enter into MDOT Contract No. 14-5130, Job. No. 114111 and to do all things necessary to fulfill all provisions of the contract. Funding for said contract will be made available in account 202-441.702-801.000.


