This study will allow us to further implement strategies from the Master Plan that focus on retaining and recruiting new residents to Flint through diverse housing options that create increased density within anchor areas and focusing on neighborhood nodes of activity. Our City currently possesses tremendously high occupancy rates within existing multi-family and mixed-use residential options. This study can serve as an important example of the City's commitment to revitalization.

The estimated budget for the TMA will be approximately \$30,000. The \$15,000 MSHDA grant will provide \$15,000 and The Genesee County Habitat for Humanity has committed to provide the remaining \$15,000 matching funds. (See attached agreement letter from Habitat).
