TO REV. DR. F. O. HOCKENHULL PLACE**


**BY THE EMERGENCY MANAGER:**

It is the desire of this City to honor and recognize Rev. Dr. F. O. Hockenhull for the beautification and revitalization efforts to the 3 block area between 7th Street and 8th Street during his 43 years of service as Pastor of First Trinity Missionary Baptist Church and to support the City of Flint through his dedication of community service; and

On May 27, 2014 the City of Flint Planning Commission has held a public hearing, reviewed the request for such renaming, and forwarded same to the Emergency Manager with a recommendation to approve the alley name change of Mitchell Alley between 7th Street and 8th Street to Rev. Dr. F. O. Hockenhull Place.

**THEREFORE BE IT RESOLVED**, that the Emergency Manager finds and determines that a portion of a City of Flint alley, from 7th Street to 8th Street, currently known as Mitchell Alley, shall be named Rev. Dr. F. O. Hockenhull Place. The renaming shall become effective immediately.
