RESOLUTION AUTHORIZING ENTERING INTO A CONTRACT BETWEEN RUBE'S BAR & GRILL AND THE CITY OF FLINT TO PROVIDE AND ADMINISTER A CERTIFIED POLICE OFFICER

## BY THE MAYOR:

Rube's Bar & Grill has proposed to finance a certified police officer on overtime every Thursday, Friday, Saturday and Sunday from 11:30 p.m. to 2:30 a.m. each day.

The City of Flint joins Rube's Bar & Grill in working towards their mutual goal of a safer business and community. The City will provide a certified police officer, trained and supervised by the Flint Police Department to achieve their mutual goals of crime prevention and personal safety.

Rube's Bar & Grill, in order to finance the certified police officer, shall pay the City of Flint the annual amount of \$38,821.09 which provides for an officer's overtime wage, benefits, and vehicle cost. Rube's Bar & Grill shall pay said amount in twelve equal monthly payments which would be recognized in the Flint Police Department general fund revenue account 101-315.100-677.000.

THEREFORE BE IT RESOLVED, that the appropriate City Officials, upon the Emergency Manager's approval, are authorized to do all things necessary to enter into a contract with Rube's Bar & Grill, in the amount not to exceed \$38,821.09 for the purpose of providing a certified police officer, to work Rube's Bar & Grill regarding crime prevention and personal safety in return for payment to cover an officers overtime wage, benefits and vehicle cost.
