At the time the resolution was approved, the company was in bankruptcy, but working on a reorganization plan. If not finalized in time, the City may have to, again, use its CDBG funds to cover debt service for this loan.

RESOLVED, that the Emergency Manager has authorized appropriate City Officials to do all things necessary to allocate CDBG funds in the amount of \$502.50 to reimburse the 295 Fund for principal and interest payments associated with the MI Timber and Truss Section 108 business loan for fiscal year 2014 and authorize CDBG funds to cover future debt service until such time that such payments are included in the company's reorganization plan.
