***Resolution Authorizing entering into a grant agreement with the United Way of Genesee County for participation in a Community Radio Patrol Grant funded by the Ruth Mott Foundation***

**BY THE EMERGENCY MANAGER:**

The City of Flint Police Department has been awarded grant funds, in the amount of \$49,570.00, from the United Way of Genesee County for the purpose of participating in a Community Radio Patrol Grant for the period July 01, 2014 through June 30, 2015; and

The Community Radio Patrol Grant is to strengthen the partnerships between various community groups and the City of Flint Police Department. This grant is to equip members of these groups with police radios that will allow for effective communication with the Flint Police Department; and

Accounts being used to set up the grant upon approval are: 296-301.614-726.000 (Supplies), 296-301.614-801.000 (Professional Services), and 296-301.614-580.000 (Revenue) all under the grant module account LUW15Poli.

**THEREFORE BE IT RESOLVED**, That the appropriate city officials are hereby authorized to do all things necessary to enter into the Community Radio Patrol Grant by and between the City of Flint and the United Way of Genesee County, and the Ruth Mott Foundation, to obtain funds in the amount of \$49,570.00 for the period of July 1, 2014 through June 30, 2015.

**BE IT FURTHER RESOLVED**, That the funds in the amount of \$49,570.00 available from this grant, be recognized by the City of Flint, and that said appropriation be made to the City of Flint Grant Fund (296FD) to be used solely for the above stated purpose as set forth in the grant agreement and related documents.


