**RESOLUTION AUTHORIZING THE EMPLOYMENT OF BRADLEY HILL AS AN ENVIRONMENTAL CONSULTANT AND SETTING COMPENSATION LEVEL**

**BY THE EMERGENCY MANAGER:**

Pursuant to the authority granted the Emergency Manager by Public Act 436 of 2012, Bradley Hill shall be employed by the City of Flint in the capacity of Environmental Consultant for the Department of Public Works. Mr. Hill's employment with the City of Flint shall be at the will of the Emergency Manager until such time as the Emergency Manager determines that his employment shall cease, or until such time as the Emergency Manager's authority terminates by operation of law; and,

Mr. Hill shall be compensated at the hourly rate of \$31.40, paid in bi-weekly installments consistent with established written policies and procedures of the City of Flint and subject to statutory tax withholding requirements; and

Mr. Hill shall not be entitled to any fringe benefits of employment; and


Mr. Hill's compensation shall be drawn from budgeted and appropriated funds in line item 590-536.101-702.000, Wages and Salaries. Further, Mr. Hill's yearly salary under the authority of this resolution shall not exceed \$22,608.00.

**IT IS RESOLVED**, that the Emergency Manager does, on behalf of the City of Flint, authorize the employment of Bradley Hill under the terms and conditions stated above. Compensation shall be at an hourly rate of \$31.40, drawn from budgeted funds in Sewer Administration line item 590-536.101-702.000, Wages and Salaries, and with statutory taxes being withheld as required by law. By virtue of this resolution Mr. Hill's salary shall not exceed \$22,608.00 per year.



**Background/Summary of Proposed Action:**

The Department of Public Works, Water Pollution Control desires to hire Bradley Hill as an environmental consultant. Mr. Hill has been working to resolve several permit issues, such as the Storm Water Management Program, with various Federal and State agencies. Because of his knowledge and expertise in regard to environmental regulations, it would be in the best interest of the City to employ Mr. Hill. Mr. Hill shall be paid an hourly rate of \$31.40, and shall not exceed 720 hours per fiscal year. The expected cost resulting from this appointment will not exceed \$22,608.00. Budgeted funding is available from wage account 590-536.101-702.000 and fringe account 590-536.101-719.100.
