Resolution authorizing entering into a grant agreement for the Auto Theft Enforcement program with Genesee Auto Interface Network (G.A.I.N.)

BY THE EMERGENCY MANAGER:

The City of Flint, through its Police Department, has been awarded grant funds through the Automobile Theft Prevention Authority Genesee Auto Interface Network (G.A.I.N.) grant program, a multijurisdictional auto theft enforcement unit organized as an interagency approach to detecting and apprehending persons involved in auto theft and related crimes across jurisdictional boundaries.

The City has been notified that the Flint Police Department is eligible to receive \$56,973.00 through this program for the period of October 01, 2014 through September 30, 2015, and that a City match in the amount of \$46,614.00 is required for the purpose of dedicating an officer to the Gain grant program. The match portion is already budgeted in the City of Flint Police Departments FY15 operating budget.

The accounts to be used for this grant is 296-301.762-702.000, 296-301.762-709.000, 296-301.762-719.100, 296-301.762-719.150, 296-301.762-719.200, 296-301.762-580.000 with grant code SOMP15GAIN and the match portion to be charged to 101-301.762-702.000, 101-301.762-709.000, 101-301.762-719.100, 101-301.762-719.150 and 101-301.762-719.200.



Background/Summary of Proposed Action: Through the State of Michigan Automobile Theft Prevention Authority (ATPA), the Genesee Auto Interface Network (G.A.I.N.) has awarded grant funds to the City of Flint Police Department in the amount of \$56,973.00 which also has matching funds in the amount of \$46,614.00. The matching funds are currently budgeted in the Police Departments FY-15 operating budget. A budget amendment will be submitted to move the funds from the Flint Police regular operating budget to the grant match accounts that are to be set-up upon acceptance of the grant. This grant runs from October 01, 2014 through September 30, 2015.

Financial Implications: Cost savings of approximately 55% of the assigned Officers wage.
