

ORDINANCE NO. _____

An Ordinance to amend the Code of the City of Flint by amending Chapter 50, Zoning, Article XXIX, Special Regulated Uses, Section 50-163.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. That the Code of the City of Flint shall be amended by amending Chapter 50, Zoning, Article XXIX, Special Regulated Uses, Section 50-163, to amend Footnote #1 only, which shall read in its entirety as follows:

**§50-163 LOCATIONAL STANDARDS –
RELATIONSHIP TO SIMILAR USES.**

(a) *Group “A” special regulated uses (§50-161).* An application to establish a group “A” special regulated use shall not be approved if there is already in existence two or more group “A,” group “B” or group “C” special regulated uses within 2,000 feet of the boundaries of the site of the proposed regulated uses.

(b) *Group “B” special regulated uses (§50-161).* An application to establish a group “B” special regulated use shall not be approved if there is already in existence four or more group “B” or group “C” special regulated uses within 2,000 feet of the boundaries of the site of the proposed regulated uses.

(c) *Group “C” special regulated uses (§50-161).* An application to establish a group “C” special regulated use shall not be approved if there are already in existence four or more group “C” special regulated uses within 2,000 feet of the boundaries of the site of the proposed regulated use.

(d) *Group “E” special regulated uses (§50-161).* An application to establish a group “E” special regulated use shall not be approved

if there is already in existence four or more group “A” or group “E” special regulated uses within 2,000 feet of the boundaries of the site of the proposed regulated use. This requirement does not apply to businesses that have continuously been open and conducting business at their current location on or before February 14, 2011.¹


Sec. 2. This ordinance shall become effective thirty (30) days following publication.
