Purpose of Program: The City of Flint formally adopted and approved its first official comprehensive master plan since 1960 on October 28, 2014. During this process, an extraordinary amount of emphasis was put towards civic and community engagement involving Flint residents. With goals of inclusion, transparency and openness, and relationship building drove City Planning staff towards dedicating thousands of hours of time to interacting with Flint community members. From this, a tremendous amount of momentum and community buy in was generated.
