Resolution Authorizing entering into a grant agreement with Flint Township for participation in a Multi-jurisdictional Edward Byrne Memorial Justice Assistance Grant (JAG) funded by the Department of Justice

BY THE EMERGENCY MANAGER:

The City of Flint Police Department has obtained grant funds, in the amount of \$191,021.00, from Flint Township for the purpose of participating with other police agencies in a multi-jurisdictional grant, known as the Justice Assistance Grant (JAG); and


The Justice Assistance Grant is a four-year grant, funded by the Department of Justice, with no local match required. The funding from this grant allows for overtime initiatives for targeted enforcement within the police department, Uniforms, Equipment and vehicles for enhanced criminal justice services; and

Accounts being used to set up the grant upon approval are: 296-301.600-709.000 (Overtime), 296-301.600-758.000 (Uniforms), 296-301.600-977.000 (Equipment), 296-301.600-977.500 and 296-301.600-538.000 (Revenue) all under the grant module account FDOJ2014JAG

THEREFORE BE IT RESOLVED, That the appropriate city officials are hereby authorized to do all things necessary to enter into the Justice Assistance Grant (JAG) by and between the City of Flint and Flint Township, and the Department of Justice, to obtain funds in the amount of \$191,021.00 for the period of October 1, 2013 through September 30, 2017.

BE IT FURTHER RESOLVED, That the funds in the amount of \$191,021.00 available from this grant, be recognized as received by the City of Flint, and that said appropriation be made to the City of Flint Grant Fund account (296FD) to be used solely for the above stated purpose as set forth in the grant agreement and related documents.


