ORDINANCE NO.

An Ordinance to amend the City of Flint Code of Ordinances by amending Chapter 12, Business and Occupations Generally; Article VIII, Junk Dealers, Secondhand Dealers, Pawnbrokers and the Like; Division 2, Junk Dealers, Secondhand Dealers and the Like.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. That the Ordinances of the City of Flint shall be amended by amending Chapter 12, Business and Occupations Generally; Article VIII, Junk Dealers, Secondhand Dealers, Pawnbrokers and the Like; Division 2, Junk Dealers, Secondhand Dealers and the Like; by the addition of new subsections (d) and (e) to §12-64, Posting of Business Sign; Records Required to be Kept, which shall read in its entirety as follows:

§ 12-64 POSTING OF BUSINESS SIGN; RECORDS REQUIRED TO BE KEPT.

Every person licensed under this article shall post in a conspicuous place in or upon his shop, store, wagon, vehicle, barn or other place of business, a sign having his name and occupation legibly inscribed thereon, and shall keep a separate book, or electronic record, open to inspection by members of the police force, Sheriff's office and other public officers, in which shall be written in the English language at the time of the purchase or exchange of such article or junk all information required under the applicable ordinances in this article and the following:

> (a) A description of such articles or junk; including salvaged iron, aluminum, brass, lead, copper and other base metal and their compounds or combinations, the quantity and/or weight of such items;

(b) The name description and residence of the person, including the driver's license number and the vehicle license number or a non-driver's license identification number, from whom the same was purchased and received; AND A PHOTOGRAPH OF THE PERSON TAKEN AT THE TIME OF EXCHANGE; and

(c) The day and hour when the purchase or exchange was made.

(D) REPORTS MUST BE ELECTRONICALLY

TRANSMITTED TO THE CHIEF OF POLICE, OR HIS DESIGNEE, IN A FORMAT CHOSEN BY THE CHIEF POLICE WITHIN FORTY-OF EIGHT (48) HOURS OF ACCEPTANCE. THE REPORT MUST BE TRANSMITTED AN **ELECTRONIC** THROUGH **INFORMATION DATA MANAGER** DESIGNATED BY THE CHIEF OF POLICE TO FACILITATE THE **COLLECTION** AND TRANSMISSION OF SUCH **REPORTS. THE REPORTS SHALL BE IN A FORMAT DESIGNATED BY** THE CONTRACTOR OR SERVICE **PROVIDER. THE REPORT SHALL** ALL **IDENTIFYING** INCLUDE MARKS OR OTHER UNIQUE DESCRIPTORS THAT DISTINGUISH THE PROPERTY FROM SIMILAR ITEMS. ALL PRECIOUS JEWELRY AND **METALS** OR GEMS, **SCRAP** METAL. AND ANY **OTHER** PROPERTY THAT DOES NOT HAVE A SERIAL NUMBER, OR A **PRODUCT NAME, OR A MAKE AND** SHALL MODEL, BE PHOTOGRAPHED FROM THREE ANGLES AND THE PHOTOGRAPHS SHALL BE INCLUDED WITH THE **REPORT.**

(E) ALL SECONDHAND MERCHANTS MUST HAVE THE EQUIPMENT OR SOFTWARE NECESSARY TO TRANSMIT THE REQUIRED REPORTS THROUGH THE ELECTRONIC INFORMATION DATA MANAGER DESIGNATED BY THE CHIEF OF POLICE BY JANUARY 1, 2015.
