Re-shingle House and Garage

The applicant explained that he would like to replace old shingles with new ones on the roof of the house, garage and porch. The new ones they'd like to use are architectural and look like the shingles the neighboring houses within the cul-de-sac have on them already, for a cohesive look to the neighborhood. Torch down will be added to the back side. The applicant explained that the shingles will overlap slightly instead of being flat right next to each other.
