The people of the City of Flint adopted the Flint City Charter on November 5, 1974 – and as a result was printed by the Authority of the Flint City Council.

After the abovementioned date, (1974), there were periodic amendments to The City Charter up to and including those published in the second printing of the Charter dated March 1, 1996.

Since March 1996, there have been a total of Sixteen (16) Charter Amendments adopted by the People of the City of Flint from August 6, 1996 through November 3, 2015. These amendments will be included and published in the future (third) printing of the Charter.

4-202 – EXECUTIVE STAFF

Sections (A) and (C) are amended to reduce the number of Mayoral Principal staff appointments for legal counsel and administrative services from no more than (10) to no more than five (5).

6-201 BOARD OF HOSPITAL MANAGERS

Establishment, Membership, Appointment

Section 6-201 of the City Charter is amended to expand the Board of Hospital Managers appointed by the mayor with council approval from eleven (11) to fifteen (15) members, modifies qualifications to be a board member to require all members except for compelling reasons stated before appointment, be residents of the City of Flint with at least $\frac{3}{4}$ of the board members residents of the City and allow not more than three members of the Board to be members of a medical or health profession, with all Board Members continuing to serve beyond their terms until replacement is appointed.

6-202 POWERS AND DUTIES

Section 6-202 of the City Charter is amended to change the job title terminology provided for Board appointments and authorize the Board to appoint a President and CEO (formerly Director) for each of the City hospital facilities and a Vice President of Human Resources (formerly Personnel Director) and appropriate Vice Presidents (formerly a Comptroller, a Director of Nursing and six (6) Assistant Hospital Directors) for each City Hospital facility.

7-201 TAXING POWER

Section (A)

(1) During the period July 1, 1996 through June 30, 2001, the City of Flint is authorized to levy taxes at the rate of two-tenths of one percent, two dollars (\$2.00) per thousand dollars (.2 of 1% or 2 mills) of the taxable value of all real and personal property in the City, with all revenue received being used solely for the purpose of a city-wide community police program.

Adopted 8-06-1996

(2) During the period of January 1, 1997 through December 31, 2006, the City of Flint is authorized to increase the total rate limitation by 50 cents (\$.50) per thousand dollars (\$1000) (.50 mill) on the taxable value of all real and personal property in the City with all revenue received being dedicated solely for the purpose of improvements and maintenance of City parks, forestry and recreation services.

Adopted 8-06-1996

(3) During the period July 1, 1996 through June 30, 2001, the City of Flint is authorized to increase the total tax rate limitation by 60 cents (\$0.60) per thousand dollars (\$1000) (.60 mill) on taxable value of all real and personal property in the City with all revenue received being used to fund public transportation services in the City by the Flint Mass Transportation Authority. (MTA) **Adopted 8-06-1996**

7-201 TAXING POWER

Section (A)

(1) During the period July 1, 2001 through June 30, 2006, the City of Flint is authorized to levy taxes at the rate of two-tenths of one percent, two dollars (\$2.00) per thousand dollars (.2 of 1% or 2 mills) of the taxable value of all real and personal property in the City, with all revenue received being used solely for the purpose of a city-wide community police program. **Adopted 8-17-2001**

(3) During the period July 1, 2001 through June 30, 2006, the City of Flint is authorized to increase the total tax rate limitation by 60 cents (\$0.60) per thousand dollars (\$1000) (.60 mill) on taxable value of all real and personal property in the City with all revenue received being dedicated to funding public transportation services in the City by the Flint Mass Transportation Authority. (MTA) **Adopted 8-17-2001**

(3) During the period of July 1, 2006 through June 30, 2011, the City of Flint is authorized to increase the total tax rate limitation by 60 cents (\$.60) per thousand dollars (\$1000) (.60 mill) on the taxable value of all real and personal property in the City, with all revenue being dedicated to funding public transportation services in the City by the Mass Transportation Authority. (MTA) **Adopted 8-02-2005**

City Wide Community Police Program
Millage Renewal

(1) During the period July 1, 2006 through June 30, 2011, the City of Flint is authorized to levy taxes at the rate of two-tenths of one percent, two dollars (\$2.00) per thousand (.2 of 1% or 2 mills) of the taxable value of all real and personal property in the City, with all revenue received being used solely for the purpose of a city-wide community police program.

Adopted 2-28-2006

[NOTE: This particular millage was NOT submitted to voters for renewal. A similar millage, Police Services, was approved by voters on 5/03/2011.]

7-201 TAXING POWER
Section (A)

Flint City Charter Amendment
City Wide Parks, Forestry, and
Recreation Program Millage Renewal

(2) During the period of January 1, 2007 through December 31, 2016, the City of Flint is authorized to renew the existing millage 0.50 mill (\$.050 per \$1,000.00) on the valuation as finally equalized from January 1, 2007 through December 31, 2016 for the purposes of funding city wide parks, forestry and recreation programs.

(3) During the period of July 1, 2015 through June 30, 2021, the City of Flint is Authorized to increase the total tax rate limitation by 60 cents (\$.60) per thousand dollars (\$1000) (\$.60 mill) on the taxable value of all real and personal property in the City, with all revenue being dedicated to funding public transportation services in the City by the Flint Mass Transportation Authority. (MTA)

- (4) During the period of July 1, 2011 through June 30, 2017, the City is authorized to levy taxes at the rate of two (2) mills (\$2.00 per \$1,000.00) of assessed value of all real and personal property in the City, with all revenue received as a result of this provision being used solely for the purpose of providing police services.

Flint City Charter Amendment
Police and Fire Protection Millage

- (5) During the period of July 1, 2012 through July 1, 2016, the City is authorized to Levy an additional tax on real and personal property in an amount not to exceed six (6.0) mills for five (5) years for the sole purpose of providing police and fire protection.

Revision of the City Charter

City of Flint voters agreed to have a General Revision of the City Charter.

Adopted 11-04-2014

Budgetary Best Practices

The City of Flint charter is amended to provide that the annual budget presented to Council shall be accompanied by a budget message explaining the budget, to provide for multi-year financial plans and revenue projections and the establishment of a budget stabilization fund.
