Mr. Kuhn gave a brief overview of proxy voting and the Board discussed the need to develop their own policy. Currently, proxy voting for FERS is included in the money managers' fiduciary responsibilities. Mr. Kincaid requested that copies of proxy voting policies from other retirement systems be obtained and discussed as part of Mr. Day's presentation at the February Board Meeting.

19. APPROVAL OF THE FEBRUARY 1, 2011 PENSION PAYROLL TRANSFER

A motion was made by Robert Erlenbeck, and supported by Bryan Bond, to approve a transfer of \$5,141,300 for payment of the February 1, 2011 pension payroll (total estimated payroll - \$5,156,440), from the Northern Trust Flint – Drawdown Account #26-19617 to Citizens Bank. The motion carried unanimously.

20. ACTUARIAL ISSUES PENDING

 The FY09 Actuarial Valuation was presented and reviewed. Mr. Kausch noted that the
 System's funded status (assets compared to liabilities) has declined, particularly for
 General Employees (#1600, #1799, exempt), with the unfunded liability continuing to
 increase due to the number of early retirements (which increase liabilities), market
 declines, and the decreasing number of employees (which decreases employee
 contributions). The unfunded liability is expected to grow more rapidly over the next
 three years. Discussion followed. The possibility of changing the amortization for
 Hurley was also discussed.

A motion was made by Scott Kincaid, supported by Michael Townsend, to accept the Draft Fiscal Year 2009 Actuarial Valuation. The motion carried unanimously.

The Board discussed issues regarding the transfer of Hurley employees from FERS to MERS when they transfer from #1603 into other bargaining units. Attorney Robbins stated that, according to the FERS to MERS transition agreement and city ordinance, the same procedures/methodology followed in the first transfer will continue, including payment by Hurley for GRS calculations of asset transfers. Chairman Bingaman asked GRS and HMC to work together to resolve any issues.

- ♦ Pension Calculation Errors Lawsuits Kelly Remand Order (Agenda Item #14.1) Attorney Robbins reported that Judge Farah remanded this case back to the Board and specifically ruled that Robert Erlenbeck and Peter Dobrzeniecki cannot take part in the Board's decision (Mr. Dobrzeniecki is no longer a member of the Board). The Judge also ruled that the burden of proof will be on the City. Ms. Robbins noted that the Board has a fiduciary duty to consider all records, testimony and documentation, basing their decisions on the testimony of the evidence. The issue is whether or not there was an error. Mr. Kelly's attorney will be contacting her regarding availability dates for his hearing. The hearings should be scheduled with the Board in the order the requests were received.
- ♦ Pension Calculation Errors Lawsuits Burns/Wiggins/Doerr The mediation proposals were rejected and the hearings stayed until the conclusion of the Kelly hearing.

- ◆ Hurley Employee Transfers to Exempt Status & MERS (ongoing) Board discussion. Attorney I'Lanta Robbins stated that the ordinance is clear that the same method used for the original transfer will be used for all subsequent transfers.

- ◆ Lesa Keeley The Board previously approved the error recalculations. The GRS actuarial reduction calculations for the repayment have been received (\$5169.24 \$36.08/month deduction). A letter will be sent to her outlining the repayment options and indicating that the Board is not involved in any contract negotiations and is moving forward with their obligation to correct errors, per the Ordinance.
- ♦ Flint Housing Commission (FHC) Employee An individual whose job was eliminated when the FHC separated from the City was given a severance and allowed to purchase generic time to add onto his years of service to reach the ten-year vesting, pursuant to the Local #1600 contract provision. The calculation used for purchasing his generic time used age 55 as his collection age. However, the early retirement job elimination provision also allows individuals to begin collecting a pension when they would have had 20 years of service. He did not indicate his intention to do so. If he begins collecting a pension in 2014 (the 20 years of service date), he should have paid an additional \$10,100 to purchase this time using the younger retirement collection age as a factor. The Professional Services Committee recommends that a letter be sent to the individual informing him that he is vested in the Retirement System and, with the amount he paid for the generic time, he is eligible to begin collecting a ten-year pension at age 55. If he wishes to pay the additional amount for the generic time based on an earlier age of pension collection, he can begin collecting in 2014. Discussion followed.

A motion was made by Sherry Murphy, supported by Scott Kincaid, that a letter be sent to this individual to give him the option of collecting a pension at age 55, as originally calculated, or paying the additional funds to receive a pension when he would have had 20 years of service. Motion carried unanimously.

A motion was made by Mark Stratman, supported by Sherry Murphy, to approve a non-duty disability retirement pension for Bruce Schneder based upon physician restrictions and the City's Human Resources Department stating that no positions are available with his restrictions. The motion carried 7-1.

♦ Amy Rogers – City of Flint/Police Dept. (Response received from Dr. Roth)

Dr. Roth was waiting for additional medical information regarding Ms. Rogers due to her ongoing rehabilitation; he has now recommended approval for a disability pension.

A motion was made by Scott Kincaid, supported by Bryan Bond, to approve a non-duty disability pension for Amy Rogers. Motion carried unanimously.

♦ Terry Harris – Hurley Medical Center (Agenda Item #14.6)

Dr. Roth's report stated that Terry Harris could work with restrictions; however, HMC Human Resources has indicated that there is no position available for an employee with those restrictions. The Committee recommends that a non-duty disability pension be approved.

A motion was made by Michael Townsend, supported by Mark Stratman, to approve a non-duty disability retirement pension for Terry Harris based upon physician restrictions and Hurley's Human Resources Department stating that no positions are available with those restrictions. The motion carried 7-1.

♦ Payroll issues

Denise Bingaman reported that City Administration is considering converting active payroll to a direct deposit/paycard system and asked whether the Board would support a similar system for retiree payroll. Currently, only 300 out of 2800 retirees receive checks, with the rest receiving advice statements. It would save a considerable amount of money if retiree payroll were converted (with retirees' agreement): 1) advice statements could be eliminated and the information provided online, 2) checks could be eliminated and paycards offered for those who do not want direct deposit. A big advantage for the retirees would be that the paycards would allow the funds to be available on the first day of the month, the same as direct deposits. Paychecks are currently mailed on the first of the month and received a few days later. The new procedure would involve each retiree setting up a secure online account with the City and, once they can access their payroll information, we could discontinue sending them an advice statement. Discussion followed. This could be mandatory for new retirees. Forms are already available online for completion and can be e-mailed to the Retirement Office. City Ordinance language requires "pay" without specifying the form and State law now allows employers to choose to pay by paycheck or direct deposit or paycard. Attorney Robbins will review legal issues. Could the retirees be given the option to individually access their advice statements online or accept paycards if they do not wish to receive their pension by direct deposit?

A motion was made by Michael Townsend, supported by Cass Wisniewski, authorizing correspondence to be sent to retirees offering the option to receive their advice statements online and to receive their pension payments via direct deposit or paycard. Motion carried unanimously.
