Attorney VanOverbeke gave an overview of the Emergency Manager laws and answered questions regarding their potential effects on the Board and the Retirement System. The Governor of the State of Michigan has announced that he will be appointing an Emergency Manager for the City of Flint, in accordance with Public Act 4 of 2011, which broadens the powers of an EM from the State's Public Act 72 (enacted in the 1990s). These additional powers include authority over retirement systems. An EM has the ability to remove and replace trustees (with the approval of the State Treasurer) and/or appoint himself to the Board to replace a trustee (ex.: City Administrator or City Council member) or become the sole trustee. However, the EM must serve as a true fiduciary, making decisions in the best interests of all plan members and beneficiaries. If the funding level is below 80%, he can also recommend to the State that the System be merged into another retirement system. If below 80% and the Treasurer approves his recommendations, an EM can fire consultants, banks or money managers, change the asset allocation, and/or adopt a new investment policy. Discussion followed.

Attorney VanOverbeke noted that Article 9, Section 24 (1963) of the State Constitution protects accrued financial benefits (pensions) from diminishing or impairment. The EM must ensure that retirees get the pension they are entitled to. Health care is protected under Article 1, Section 10, from *substantial impairment*, according to a Court of Appeals ruling. The EM must comply with PA 314 and must fund normal costs of providing pensions, as well as a portion of the unfunded accrued liability over the 30 year current amortization.

Mr. VanOverbeke also discussed administrative hearing procedures with the Board, noting that a Committee can be appointed to conduct the hearings and make recommendations to the Board, rather than having the entire Board attend the hearings. He emphasized the legal importance of granting due process and holding hearings, when requested, in as timely a manner as possible, which is part of Trustees' fiduciary responsibility.

Regarding the Freedom of Information Act request from Habeeb Ghattas, Attorney for David Plewes, Attorney VanOverbeke will discuss the Board's response with Attorneys Robbins and Lawson. FOIA law requires release of public information, regardless of the purpose of the request, unless certain exemptions apply; for example, Attorney-Client Privilege. Wage and pension information of public employees is public information; however, FOIA requests cannot be an unwarranted invasion of individuals' rights to privacy.

A motion was made by Cass Wisniewski, supported by Bryan Bond, to concur with Dr. Roth's recommendation that Darren Chaddock is totally and permanently disabled and should be granted a non-duty disability retirement pension. The motion carried unanimously.

Attorney Robbins noted that there has been a problem getting a quorum so that hearings can be held. She will be working with plaintiffs' attorneys to schedule hearings, possibly more than one in a month until they are caught up. Discussion followed. Attorney VanOverbeke noted that the Board's fiduciary responsibilities include holding timely administrative hearings, when requested. He also noted that Trustees can only administer the Plan as negotiated and adopted by the Plan document / Ordinance; the Board does not have equitable jurisdiction (like the Courts) to make decisions on issues outside the scope of the Plan document provisions. He recommended that the administrative hearing guidelines be revised to allow a half hour limit on each side. Legal opinions could be submitted for prior review, and only a small amount of witness testimony should be needed to address issues within the Board's scope. The Board could choose to appoint a hearing officer or a committee to conduct hearings and make recommendations to the full Board. Judges can only overturn decisions if they are found to be arbitrary or capricious. Discussion followed. Attorneys Robbins and VanOverbeke will review current procedures and make recommendations.
