## 18. GRAY & COMPANY – CONSULTANT'S REPORT/RECOMMENDATIONS

Consultant Ivory Day presented and reviewed the following reports, with Board discussion following:

- ♦ Schedule of Asset Classes, Manager Allocation & Re-Balancing
- ◆ 2nd Quarter Performance Report (June 30, 2011)
- ♦ Market Update (Ref. Agenda Item #14.4 & packet of information distributed at meeting)

During discussion, Cass Wisniewski noted that **GASB** is changing the accounting rules for unrecorded pension liabilities. Chairman Bingaman stated that he would ask David Kausch from Gabriel Roeder Smith & Co. to address the Board next month regarding this issue and how it could affect investment allocation.

The Board discussed the FERS' Investment Policy, which requires that the System only invest in AAA rated collateralized mortgage obligations, and the impact of the downgrade of the US bond rating. Mr. Day recommended an amendment to the Investment Policy. He will write the amendment for review by Attorney Robbins and subsequent adoption by the Board and notification to the money managers.

- ◆ Proxy Voting Mr. Day reported that he and the compliance staff at Gray & Company reviewed the proxy information that was received from the six equity managers, per the Board's request. He recommended that he contact all the managers and request a summary report to better explain what is voted and why. He will also review the process and parameters used by the four proxy voting organizations in the U.S. The Board can write their own policy; currently, each money manager has their own proxy voting guidelines and votes in accordance with what they believe is best for their plan and their customers. Discussion followed.

## 19. APPROVAL OF THE SEPTEMBER 1, 2011 PENSION PAYROLL TRANSFER

A motion was made by Scott Kincaid, and supported by Cass Wisniewski, to approve a transfer of \$3,274,900 for payment of the September 1, 2011 pension payroll (total estimated payroll - \$5,225,664), from the Northern Trust Flint – Drawdown Account #26-19617 to Citizens Bank. The motion carried unanimously.

## 20. ACTUARIAL ISSUES PENDING

♦ **Fiscal Year 2010 Actuarial Valuation** – *Status - data collection -* Suzi Bye reported that she is continuing her work on recalculating and reconciling retirement savings and service credits for every participant manually due to the large number of errors found and the potential impact on the actuarial valuation. She will send the corrected data to the Actuary as soon as it is available.

# **21. LEGAL COUNSEL UPDATES** – I'Lanta Robbins, Attorney for Retirement Board

- ♦ Take Two Interactive Lawsuit Securities Fraud Loss \$176,505 Settlement pending
- ◆ Capital BidCo Attorney Robbins has been in contact with the general counsel for the Lansing Board of Water and Light regarding the investigation by the State of Michigan and their questions about this fund. The Lansing management has decided not to pursue the matter further. It appears that the State of Michigan is not conducting an investigation but has, in fact, stated they have no record of the request. She recommended further discussions with the Finance Committee regarding whether to resubmit the investigation request or discontinue further efforts. There has been no response to questions directed to the gentleman overseeing dissolution of the fund. Discussion followed. Attorney Robbins will contact the Lansing Board to determine their reasons for dropping this issue. The question was also raised regarding the possibility of a professional liability insurance policy that may have been held by Capital BidCo. Chairman Bingaman referred the issue to the Finance Committee for further discussion.
- ♦ Pension Calculation Errors Lawsuits Hearings to be scheduled
  - O Sheila Burns (5 "free" years in FAC) Attorney Gibbs requested a hearing date of November 15. The Court has ruled on which Board Members may vote on the hearings, indicating that Ms. Bland and Ms. Murphy and Ms. Bingaman may not vote; however, Mr. Bingaman may vote. Mr. Erlenbeck is also ineligible to cast a vote regarding Ms. Burns' hearing since he has been called as a witness.

Attorney Robbins gave an overview of Attorney VanOverbeke's recommendation for a records retention policy, based on recent and pending litigation requiring retirement systems to be more transparent in their record keeping and have policies in place for records retention. She is recommending adoption of the policy, as it is in accordance with State statutes and Freedom of Information Act requirements. Discussion followed. The question was raised whether the policy could cause future legal issues because previous record keeping may not have included documents that are required in the policy. Does the Board need to identify which historical records are not available and can only be kept going forward? Attorney Robbins will contact Attorney VanOverbeke regarding disclosure requirements and legal ramifications in the case of lawsuits requesting historical documents that do not exist but are outlined for retention in the policy.

## 22. PROFESSIONAL SERVICES COMMITTEE

Denise Bingaman reported that the Committee met (two members were missing) and discussed the following:

  - o **Pension Advice Mailing** discontinued mailing 560 statements, per retirees' requests
  - Pay/Debit Cards, Direct Deposit, etc. Pay cards were offered with the August 1 payroll mailing and many responses have been received requesting to switch to pay cards or direct deposit. It was noted that the City followed the bid process to select the pay card vendor based on best costs for the retiree (no cost for basic transactions) and the City and the Retirement System. This vendor is also used by other government agencies, including the Friend of the Court. The pay card is working well and is very convenient for the employees that have been using it.
  - o **Pension payroll deductions & costs to administer** A letter will be sent to the Employee Club, AFLAC, Fire Fund, POL Benefit, URGE, Hurley, City, etc. outlining the Board's fee schedule for providing the pension payroll deduction service.
