- Q2.) The water bill is currently printed on a 6-4-1/4 postcard. Is this a hard requirement, or will the City accept an alternative solution?
- A2.) The city would prefer to continue the use of printing on postcard, as the cost to send a bill and envelope are cost prohibitive.
- Q3.) Can vendors include an addendum to allow for increased compensation in the case of an unexpected materials cost increase?
- A3.) Yes, we will accept an included addendum to the submittal of proposals for this potential cost increase.

<u>PENALTY</u>. All delinquent taxes on REAL and PERSONAL property will include a 3% penalty. Interest of ½% will be added monthly.

The 1% Administration Fee was established by Public Act 388 of 1988 as a fee to offset costs incurred by the Assessment and Collection of Taxes Levied as well as the Tax Appeal and Review Process.

If the name and/or address on your tax statement are not correct, please notify the Assessor's Office at the City of Flint (810) 766-7255.

Please note: THE TREASURER DOES NOT WAIVE PENALTIES OR REDUCE THE AMOUNT OF YOUR TAX BILL. This office merely collects and distributes taxes levied by the taxing bodies in Genesee County.
