FY2016/Budget Adjustment (Amendment)/Transfer of Funds/Reprogramming/Community Development Block Grant (CDBG) Funds

Resolution resolving that the appropriate City of Flint officials are authorized to do all things necessary to process a budget amendment to move \$266,143.00 from FHUD15CDBG Acct. No. 274-748.107-702.000 = \$79,019.24, Acct. No. 274-748.107-709.000 = \$300.00, Acct. No. 274-748.107-719.100 = \$8,289.12, Acct. No. 274-748.107-719.150 = \$53,224.96, Acct. No. 274-748.107-719.155 = \$1,090.00, Acct. No. 274-748.107-719.200 = \$27,732.48, and Acct. No. 274-748.107-801.000 = \$96,487.20 to FHUD15CDBG Revenue Acct. Contract/Sorenson Gross Construction/Riverbank Park Improvements

Resolution resolving that the Mayor and City Administrator are authorized to enter into a contract with Sorenson Gross Construction for Riverbank Park Improvements Phase II, as requested by Parks and Recreation, in an amount NOT-TO-EXCEED \$345,600.00 [Park/Recreation Fund Acct. No. 208-752.102-801.000 = \$70,000.00 and SMDNR14PARK Acct. No. 296-690.395-801.000 = \$275,600.00]. [NOTE: On July 27, 2015, City Council approved Resolution No. 150560, which authorized the Mayor and City Administrator to enter into a contract with Sorenson Gross Construction. The Purchasing Department omitted an account number that was to be included as part of the funding.] [City Administrator Submission No. CA0582015.1.]

This resolution was submitted by the administration to replace Resolution No. 150560, which was adopted by the City Council on July 27, 2015, due to incomplete account numbers. City Council will need to move this resolution to the August 10, 2015, Committee-of-the-Whole Meeting. At the same meeting, City Council will need to **RECONSIDER** 150560 and drop it.
