ORDINANCE NO. \_\_\_\_\_

An Ordinance to amend the Flint Code of Ordinances, Chapter 30, Nuisances, by the addition of Section 30-40.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF FLINT:

Sec. 1. An Ordinance to amend the Flint City Code of Ordinances by amending Chapter 30, Nuisances, by adding Section 30-40, Reckless Driving, which shall read in its entirety as follows:

§30-40. RECKLESS DRIVING

(A) ANY MOTOR VEHICLE USED FOR THE PURPOSE OF RECKLESS DRIVING IN A RESIDENTIAL NEIGHBORHOOD IN THE CITY OF FLINT IS DECLARED A NUISANCE. ALL SUCH NUISANCES ARE SUBJECT TO ENJOINMENT AND ABATEMENT AS PROVIDED UNDER STATE AND LOCAL LAW. ANY PERSON, OR HIS AGENT OR EMPLOYEE, WHO OWNS, LEASES, OR OPERATES A MOTOR VEHICLE IN VIOLATION OF THIS SECTION IS GUILTY OF A NUISANCE.

(B) THE CITY ATTORNEY MAY MAINTAIN AN ACTION FOR NUISANCE ABATEMENT EQUITABLE RELIEF IN THE NAME OF THE CITY OF FLINT IN GENESEE COUNTY CIRCUIT COURT, AND MAY SETTLE ANY SUCH ACTION FOR, AT MINIMUM, THE PAYMENT OF AN ADMINISTRATIVE FINE OF NO LESS THAN \$900 AND ALL ACCRUED TOWING AND STORAGE CHARGES.

(C) AS SET FORTH IN THIS SECTION, "RECKLESS DRIVING" MEANS CONDUCT THAT VIOLATES MCL 257.626, OR OTHERWISE OPERATING A VEHICLE WITH WILLFUL OR WANTON DISREGARD FOR THE SAFETY OF PERSONS OR PROPERTY, INCLUDING BUT NOT LIMITED TO THE USE OF STUNT DRIVING TECHNIQUES SUCH AS FIGURE EIGHTS, SLIDING, DRIFTING, AND DONUTS.

(D) AS SET FORTH IN THIS SECTION, "RESIDENTIAL NEIGHBORHOOD" MEANS ANY STREETS THAT HAVE A POSTED OR UNPOSTED SPEED LIMIT OF 25 MPH OR LESS.

Sec. 2. This ordinance shall become effective immediately upon publication.
