No. 274-748.184-805-336 and Smith Village Expense Acct. No. 274-748.184-805-336: FHUD13CDBG = \$525.49, FHUD14CDBG = \$9,510.22 and FHUD 15 CDBG = \$37,000.00. [NOTE: This is a change order from EMA1712015, adopted on April 20, 2015, for security patrols in the Smith Village Area. This resolution increases the contract amount \$45,000.00.]
