Genesee Conservation District (GCD)/Additional Hazardous Tree Removals/Management of City's Street Tree Activities

Resolution resolving that the Mayor is authorized to allocate an additional \$150,000.00 to the Genesee Conservation District (GCD) to provide supplemental funding to contract tree removals identified as critical removals per the tre inventory emergency tree maintenance activities, and to manage the city's street tree activities through June 30, 2018, as requested by Street Maintenance [Major Street Fund Acct. No. 202-449.215-801.000 = \$64,000.00 and Local Streets Fund Acct. No. 203-449.215-801.000 = \$86,000.00.] [NOTE: On July 9, 2012, the City of Flint entered into a partnership with GDC via a Memorandum of Understanding (MOU), which authorized GDC to manage contracts for annual hazardous tree removals, maintain a wood utilization effort, and perform community plantings throughout the city. The MOU has no expiration date, but must be reviewed and amended as deemed necessary and agreed to by the parties. On October 11, 2017, the proper city officials allocated \$150,000.00 to GCD to provide supplemental funding to contract hazardous tree removals in the City of Flint and manage the city's street tree activities through June 30, 2018.]
