#### **READING OF DISORDERLY PERSONS CITY CODE SUBSECTION**

#### 170546 Approval/One-Month Extension/Letter of Agreement/Water Service Contract/Great Lakes Water Authority (GLWA)

Resolution resolving that the Flint City Council approves the Letter of Agreement for One-Month Extension of Water Service Contract by the Great Lakes Water Authority (GLWA). [NOTE: The City of Flint's contract with GLWA is set to expire on October 31, 2017. Since the future water supply for the city of Flint has not yet been determined, the City requested a one-month extension with GLWA. GLWA will consider the City's request for an extension for the period November 1, 2017, through November 30, 2017, which will require a replenishing of the prepayment fund to cover the extended contract term. The extended contract term coincides with the new GLWA FY2018 agreement which begins on July 1, 2017. Because the extension is for a limited period of one month, GLWA has based the prepayment amounts on an average for the GLWA whole class by 4.7%. The projected FY2018 fixed monthly charge will remain the same as the prior three-month extension adopted by the Flint Receivership Transition Advisory Board (RTAB) on June 27, 2017, which was an increase of #31,100.00, and a commodity charge of \$9.35/Mcf and an increase of .42/Mcf, for a projected 30-day total of \$1,144,806.00.
